By-Law

WHEREAS the Council of the Municipal Corporation of the Hamlet of Cambridge Bay, in a duly assembled meeting, enacts as follows:

NOW, THEREFORE, THE COUNCIL OF THE HAMLET OF CAMBRIDGE BAY, at a duly assembled meeting, enacts as follows:

1. The Mayor and the Senior Administrative Officer are hereby authorized on behalf of the Hamlet of Cambridge Bay to acquire the land described in Schedule “A” (1)Western Subdivision, Plan 3939 Cambridge Bay
2. The noted land shall be acquired for municipal purposes.
